OUR COLLEGE

Tehatta Government College is nestled on the pleasant banks of the Jalangi River in the district of Nadia, West Bengal, India. The college, still under construction, besides the Kulgachi Road is a seat of heavenly beauty—partly due to the majestic river and partly due to the fertile lands that surround it—and a tranquil centre for the pursuit of knowledge. Tehatta, situated near the Bangladesh border, is a flourishing locality of Nadia District mainly because of its rich agricultural sites. Recently, Tehatta has become a sub-divisional town as well. There are two extremely high quality schools at Tehatta, one each for boys and girls. Besides that, Tehatta has been granted the rights to be a municipality and that has drawn attention of people to this quiet locality from all quarters. However, this extremely flourishing place did not have a higher education institute hitherto. The people of Tehatta had a demand for getting a college of their own so that the poor but meritorious students do not have to go far to pursue higher education.

The state government has done an admirable work by establishing this college literally on war footing. The basic ingredients of a successful college—infrastructure, human resource and intelligent students—were all present here in Tehatta itself. So, the dream of the people of Tehatta for a college of their own, a college of national standards, has become a reality.

It is heard from the locals and the government documents that the land where the college is actually set up was of Tehatta High School. Later, listening to the earnest plea of the residents of Tehatta, the Government of West Bengal decided to establish the college on this piece of land (Memo No. 6418-GE(M)/2L-296/13 Dated 06/12/2013). A two storied building has already been constructed on this 3.10 acres land by spending 5.29 crores. The work of the construction of the second floor of the main building is going on and will soon be completed. Besides the extremely spacious classrooms, the college has already got permission for a huge library and a state-of-the art conference room. These plans will be soon materialized. There are also proposals for the construction of a huge Science Building as well as well equipped laboratories. There is already a large playground within the college campus itself.

OUR COLLEGE

Alongside this, a beautiful water body and a beautiful flower garden are being made. There is a plan in place to develop an herbal garden as well. There is also a huge cycle garage keeping in mind the need of the students. The foundation stone of this college was laid on 28th February, 2014. This day is celebrated as the foundation day of Tehatta Government College with utmost grandeur. The college received its affiliation from Kalyani University on 21st May, 2015 (Order No. 705-(A)/4C-12a/97(pt) vide memo No. RPS/Aff.Coll./71/347/2015/S-17). Within merely one and a half year of its foundation, the college started its journey and the much awaited teaching-learning process also started from the academic session 2015-16. It is from this above mentioned time that the college has started offering honours and general courses in Bengali, English, History, Political Science and Philosophy. Very soon, Honours and Pass courses in Sanskrit and Sociology, in arts stream, will be offered. The college is waiting to get approval to introduce courses in Mathematics, Physics and Chemistry in Science Stream.

The first person to hold office in Tehatta Government College was Dr. Gobardhan Rano, the young professor of Mathematics, who was posted from a renowned government college of Nadia District as officer-in-charge to look after the growth and well-being of the college. After a short while, two more professors, Dr. Sibsankar Pal and Dr. Manjari Ghosh, coming from prominent government colleges and with vast amount of experiences, took charges of their respective offices. Then, two more young teachers, Sri. Raghunath Roy and Sri. Malay Das, coming from two highly reputed government colleges of the state, joined the college after a short while. The earnest efforts put in by the officer-in-charge and these concerned teachers transformed this infant college into a healthy and efficient centre for pursuing quality education and excellence. The joining of many more young, exuberant and freshly minted teachers has furthered this process even more. Amongst the many newly established government college, Tehatta Government College has already made its mark as a distinct force in the field of higher education. The administration of Tehatta Government College hopes that with the ceaseless effort of the teachers, non-teaching staffs, students, the local people and the local administration, the college will soon be one of the pioneering institutions of the state in cultivating the merit of the students.

A candidate taking up Honours Course for B.A. Degree shall study-

- i) Honours in any one subject of the Humanities Division and any other two subjects in the General courses taking at least one from the Humanities Division.
- ii) Two Compulsory Languages. (Bengali and English)
- iii) Environmental Studies.

A candidate taking up General Course for B.A. Degree shall study-

- i) Any three subjects from the Humanities Division. (Bengali, English, History, Pol.Sc, Philosophy)
- ii) Two Compulsory Languages. (Bengali and English)
- iii) Environmental Studies.

A candidate taking up General Course for B.Sc. Degree shall study-

- i) Any three subjects from the Science Division (Physics, Chemistry, Mathematics)
- ii) Two Compulsory Languages. (Bengali and English)
- iii) Environmental Studies.

NORMS TO BE FOLLOWED

STUDENTS MUST REMEMBER

- Serious notice is taken of unwarranted absence from classes and college examinations. The College Authority reserves the right to strike off the name of the student if he / she is found to be continuously absent without intimation for 21 days after the commencement of classes.
- A student absent from college for three continuous months without notice will be struck off from the college roll.
- Students of this college will abide by the rules of the college and must conduct themselves with decorum decency.
- “Students must also note that it is mandatory as per the Hon. Supreme Court & the UGC Regulations that all students should fill in an Anti Ragging Affidavit, each year. To make the process easy MHRD has developed an ONLINE Facility.”
- Admission to the college binds a student to follow college rules and directions that may be issued from time to time by the college authority.
- Students must carry their identity cards and he/she should produce the identity card on prosecution at any time for any reason.
- Students are required to attend the lectures regularly and punctually. At least 75% attendance is required to appear in final examination.
- Loitering in the corridor/campus without any valid reason and attending to cell-phone calls inside the classroom are strictly prohibited.
- Students are required to follow the notice board every day for relevant information.
- Students have to attend classes as per norms and should qualify in the College Test(s) to be allowed to write the Final University Examination.
- Smoking and spitting in the college premises are strictly forbidden.
- Till the notification of the result of the final examination the students are considered to be the bonafide present students of the college.

NORMS TO BE FOLLOWED

STUDENTS MUST REMEMBER

- ✉ All the rules and regulations of the college declared at different times of an academic session should be followed and obeyed by the students.
- ✉ Participation in games, sports and cultural programmes is mandatory.
- ✉ Other than any satisfactory reasons, presence of students in tutorial classes is mandatory.
- ✉ Absence of a student from any examination in the college shall be treated as an act of misconduct and breaking the discipline of the college. If a student is unable to appear in one or more examination, he/ she should submit relevant evidence of his /her absence to the Principal, countersigned by the guardian.
- ✉ Guardians should attend the Parents'- Teachers' meetings held in the college, organized by the Parents- Teachers Council.
- ✉ There is a Grievance Redressal Cell where students and their guardians may lodge complaints if and when required.
- ✉ Ragging is strictly prohibited in the college. If anyone is found guilty of ragging shall be punished according to the Court of Law. It is also to be noted that during admission, students and their guardians are supposed to submit an anti ragging affidavit as directed by the Supreme Court. ELIGIBILITY CRITERIA FOR ADMISSION

1. A candidate may be admitted to the first year of three-year B.A./ B.Sc./ B.Com.(Honours/ General/ Major) Courses of Studies on passing Higher Secondary (10+2) Examination in General or Vocational Stream conducted by the West Bengal Council of Higher Secondary Education or an equivalent examination conducted by other State Board / Council, or, Rabindra Mukta Vidyalaya, or, National Open School recognized by the Distant Learning Council **subject to fulfilment of the conditions mentioned below:**

In case of other Boards/ Councils, a candidate shall have to pass in five recognized subjects, of which one shall be English, of full marks not being less than 100 each. A candidate passing in four subjects shall not be eligible for admission. Candidates passing Higher Secondary examination from vocational stream conducted by the West Bengal Council of Higher Secondary Education or any other equivalent board/council are eligible for admission only in General and Major courses (and not in Honours courses) provided that the candidate must have passed in 5 (five) recognised subjects, of which one shall be English, in the previous qualifying examination.

2. Candidates will be allowed for admission within 3 (three) consecutive academic sessions including the year of passing the previous qualifying examination.

(For example: candidates passing H.S. Examination in the year 2007 will get last chance of admission in the academic session 2009-2010.)

3. A candidate taking up Honours Course in a subject must have obtained:

(I) A minimum of **45%** marks in aggregate and **55%** marks in the subject or related subject at the previous qualifying examination, **Or**

(II) **50%** marks in aggregate and **45%** marks in the subject or related subject at the previous qualifying examination, **Or**

(III) **55%** marks in aggregate when the candidate has not studied the subject or any related subject in his /her previous qualifying examination provided all other clauses are satisfied (especially Rule 5).

However, candidates belonging to the Schedule Caste or Schedule Tribe Community taking up Honours Course of Study will enjoy 5% relaxation in marks in (I), (II) & (III) above, as the case may be.

ELIGIBILITY CRITERIA FOR ADMISSION

EXPLANATION:

(i) Aggregate means the sum of marks of best scored five (5) subjects excluding compulsory Environmental Education/Environmental Science/Environmental Studies. Also for old candidates (i.e., candidates passing H.S. examination before 2007) aggregate will be calculated in similar manner (i.e., on the basis of best scored five subjects) without deducting any marks for the 'Optional Elective Subject' (if any).

(ii) While calculating such aggregate full marks of each such subject will be scaled down to 100 wherever needed.

4.(a). Admission will be strictly on the basis of merit. Merit list will be prepared uniformly on the basis of the following criteria:

(i) In case of Honours courses: Aggregate (as per previous explanation) plus the marks obtained in the subject in which he/she intends to take up honours or related subject. However, students who avail themselves of the Rule 3(III) will not get the benefit of 'related subject'.

(ii) In case of Major and General courses: Merit list will be prepared on the basis of aggregate.

4.(b). For admission to Honours courses complete list of all applicants according to merit will be published at the first instance and admission will be done preferably through counselling in accordance with the intake capacity.

4.(c). For admission to Major and General courses list of applicants in order of merit will be published in accordance with the intake capacity.

4.(d). While admitting candidates from the merit list if it is found at some point of time that the approved intake is likely to be breached due to sharing of the same merit position by more than one candidate then in that case all the candidates at that particular merit position may be admitted subject to prior approval of the Vice- Chancellor and the excess admission will be granted only for that year.

ELIGIBILITY CRITERIA FOR ADMISSION

EXPLANATION:

5. Candidates may be allowed to change subject/stream/course in their first year of study, subject to approved intake capacities and various clauses of these rules, by the Principals of respective colleges before submission of Registration Form to the University or any date specified by the University, whichever is earlier. No change will be entertained after that date.
6. In the case of Foreign Candidates, Student-Visa will be required. The same visa will have to be submitted within one month from the date of admission.

NSS UNIT

Tehatta Government College has an active NSS unit which functions under the guidance of a Program Officer (Prof. Raghunath Roy) with an advisory committee of eight other members. Approximately, hundred students are engaged as volunteers in various social activities regularly along with their usual study curriculum. During the last one year, NSS unit organized special camps at Tehatta. NSS unit of this college organized two seminars ('Women's Day', 'Aids Awareness') throughout the year.

Volunteers also participated in a number of seminars, cultural programs (College Foundation Day, Rabindra Janma Jayanti, International Mother Language Day) organized by this college. Volunteers are involved throughout the year in various social activities like lime painting on the trees, tree planting, cleaning of the college campus, cleaning of the local schools and bus stand, survey in the locality regarding sanitation, hygiene, cleanliness, socio-economic status, etc.

Besides these, the NSS unit of this college played a big role in generation of sanitation consciousness and better hygiene among the residents of the adopted village 'Khaspur'. Volunteers gifted saplings to the local schools of the village. They also delivered some useful methods of handwashing before having their meals to the kids of those schools. The NSS unit is looking forward to get involved in more social and cultural activities in the next academic session.

This allows students of the College to obtain treatment at Krishnanagar Regional Center under the aegis of the program.

● GAMES AND SPORTS

The College offers various sports amenities including Football, Cricket, Bad minton, Volleyball and also some indoor games. There will be a common room for the students for playing indoor games like Table tennis, Carom etc. and a standard Football cum Cricket ground inside the premises. Annual athletic meet of the College is held in December. Students of this college take participation in University Sports meet annually.

● CULTURAL PROGRAMME

Cultural programs are held on the occasions of the Independence Day, College Foundation Day, Bhasa Dibas, Republic Day, Rabindra Jayanti, Netaji's Birthday, Annual Cultural Meet and Fresher's Welcome Ceremony. The College organizes cultural competitions and debates on different occasions. The NSS unit of the College arranges quiz competitions among students on issues of social and other concerns. Students of this college take participation in exhibition of hand crafts. The college is planning to start a film club in the near future.

● COLLEGE MAGAZINE

The College will bring out an annual magazine with an impressive collection of creative and critical writings by its students, teachers and non-teaching staff. Also, from the next session a wall magazine will be published bi-annually.
